#### The Initiative

- As a consequence of de IPv6TF (1st phase) and the EC recommendations
- Spanish Science and Technology Ministry decided to support it
- As an open task force
- Limited duration (1 year, May 2003)
- No juridical entity
- Final goal: Document(s) with concrete actions towards the complete deployment
- Kicked-off on 16<sup>th</sup> of May (key audience)





## **Objectives**

- Follow EC Recommendations
- Localize concrete recommendations for:
  - Government/administration
  - R & D & innovation
  - Education
  - Industry
  - Users
  - Others ...





### **Participants**

- Anyone WILLING to work and cooperate
  - Any entity legally established in Spain
- Including, and mainly:
  - Access an IP providers
  - Telcos (public, private, fixed, mobile, ...)
  - Hardware and Software vendors
  - Universities and R&D
  - Public (government) entities related to IP
- OBLIGATION and RIGHT to contribute for all the participants

# Steering Committee:

- Chair
- Co-chairs (the co-chairs of the WGs)
- Two representatives from Government (MCYT)
- Responsible for QC and edition of executive summary
- Decisions by consensus
  - when no reply → no objection

- Recommendations must be technically and socio-economically argumented
- Each WG must also work in:
  - Information Society repercussions
  - Business Drivers
  - Impact on national/regional R&D+Innov. programs
  - New/further studies to work on
- 3-4 plenary meetings (next one 30<sup>th</sup> September)
- Spanish, mainly via Mail exploders, FTP & Web
- No technical/commercial specs in any document





#### **Dissemination Activities**

- Proactive measures in order to generate inputs and outputs from/to society and industry
- Participation in events and conferences
- Spanish web site
- Coordination and collaboration with other IPv6 and related TF or initiatives
- Open to other mechanisms
